## **COVID-19 Confirmed Cases Age and Gender Breakdown Current as of 04/12/20, 02:30 pm**

**Carteret County, NC-** On April 12, 2020, Carteret County received another confirmed positive case for a total of 22 confirmed cases of COVID-19 in the County. Of the 22 confirmed cases, 7 patients are still active cases, 14 of those patients have recovered and have satisfied the NC Department of Health and Human Services (NCDHHS) isolation requirements, and one has died. The below chart does not represent the total number of people in Carteret County who have or had COVID-19 because not all cases of COVID-19 are tested.

**Total Confirmed Cases:** 22 (Of the 22 cases, 14 persons have recovered and fulfilled their isolation requirements per NC DHHS guidance).

\*NOTE: As you review the age and gender data, please be aware this data is preliminary and may change as cases are investigated. Percentages may not sum to 100% due to rounding. Also, the age and gender data are representative of the confirmed cases, not of all COVID-19 cases in Carteret County.
