**Carteret County COVID-19
Additional Confirmed Case Reported
Press Release #42**

Carteret County, NC – On April 27, 2020, Carteret County received another confirmed positive case for a total of 28 confirmed cases of COVID-19 for the County. Of the 28 confirmed cases, 6 patients are active cases, 19 of those patients have recovered and have satisfied the NC Department of Health and Human Services (NCDHHS) isolation requirements, and 3 are deceased. Carteret County medical providers, including the Health Department, have collected specimens for COVID-19 testing for 529 patients resulting in 28 positive confirmations, 1 inconclusive, 481 negative results and 19 pending test results.

Total Confirmed Cases: 28 (Of the 28 cases, 19 persons have recovered and fulfilled their isolation requirements per NC DHHS guidance).

*NOTE: As you review the age and gender data, please be aware this data is preliminary and may change as cases are investigated. Percentages may not sum to 100% due to rounding. Also, the age and gender data are representative of the confirmed cases, not of all COVID-19 cases in Carteret County.
