**Carteret County COVID-19  
 Additional Confirmed COVID-19 Case  
 Press Release #45**

**Carteret County, NC** – On May 3, 2020, Carteret County received an additional confirmed positive case for a total of 29 confirmed cases of COVID-19 in the County. Of the 29 confirmed cases, 5 patients are active cases, 21 of those patients have recovered and have satisfied the NC Department of Health and Human Services (NCDHHS) isolation requirements, and 3 are deceased.

Residents who are experiencing symptoms compatible with COVID-19 such as fever and cough should immediately self-isolate and contact their healthcare provider to determine if they need to be tested.

**Total Confirmed Cases:** 29 (Of the 29 cases, 21 persons have recovered and fulfilled their isolation requirements per NC DHHS guidance).

\*NOTE: As you review the age and gender data, please be aware this data is preliminary and may change as cases are investigated. Percentages may not sum to 100% due to rounding. Also, the age and gender data are representative of the confirmed cases, not of all COVID-19 cases in Carteret County.
