**Carteret County COVID-19
Additional Confirmed COVID-19 Case
Press Release #60**

Carteret County, NC – On June 7, 2020, Carteret County received a confirmed positive case for a total of 45 confirmed cases of COVID-19 in the County. Of the 45 confirmed cases, 9 patients are active cases, 33 of those patients have recovered and have satisfied the NC Department of Health and Human Services (NCDHHS) isolation requirements, and 3 are deceased. Residents should contact their healthcare provider or the Health Department to see if they meet testing criteria for COVID-19 even if they are not symptomatic.

Total Confirmed Cases: 45 (Of the 45 cases, 33 persons have recovered and fulfilled their isolation requirements per NC DHHS guidance).

*NOTE: As you review the age and gender data, please be aware this data is preliminary and may change as cases are investigated. Percentages may not sum to 100% due to rounding. Also, the age and gender data are representative of the confirmed cases, not of all COVID-19 cases in Carteret County.
