Carteret County COVID-19
Two Additional Confirmed COVID-19 Cases
Press Release #63

Carteret County, NC – On June 12, 2020, Carteret County received another two confirmed positive cases for a total of 52 confirmed cases of COVID-19 in the County. Of the 52 confirmed cases, 13 patients are active case, 36 of those patients have recovered and have satisfied the NC Department of Health and Human Services (NCDHHS) isolation requirements, and 3 are deceased. Residents should contact their healthcare provider or the Health Department to see if they meet testing criteria for COVID-19 even if they are not symptomatic.

Total Confirmed Cases: 52 (Of the 52 cases, 36 persons have recovered and fulfilled their isolation requirements per NC DHHS guidance).

*NOTE: As you review the age and gender data, please be aware this data is preliminary and may change as cases are investigated. Percentages may not sum to 100% due to rounding. Also, the age and gender data are representative of the confirmed cases, not of all COVID-19 cases in Carteret County.
