**Carteret County COVID-19
Resident Death Related to COVID-19
Press Release #82**

Carteret County, NC – Carteret County Health Department regrets to inform that the County received a report of a confirmed COVID-19 death of a Carteret County resident. The individual died November 7, 2020 from complications associated with the COVID-19 virus. The resident was in their 70s and had preexisting health conditions. To protect the family’s privacy, no further information about this patient will be released.

“The Health Department sends our condolences to the family and loved ones of this resident.” stated Health Director, Stephanie Cannon. The Health Department encourages all residents to follow the 3Ws as a prevention measure to help slow the spread of COVID:

1. **W**ear a mask/face covering:
