## **COVID-19 Confirmed Cases Age and Gender Breakdown Current as of 04/09/20, 11:30 am**

**Carteret County, NC-** On April 9, 2020, Carteret County received another confirmed positive case for a total of 20 confirmed cases of COVID-19 in the County. Carteret County medical providers, including the Health Department, have collected specimens for COVID-19 testing for 355 patients resulting in 20 positive confirmations, 1 inconclusive, 315 negative results and 19 pending test results. Of the 20 confirmed cases, 6 patients are still active cases, 13 of those patients have recovered and have satisfied the NC Department of Health and Human Services (NCDHHS) isolation requirements, and one is deceased.

**Total Confirmed Cases:** 20 (Of the 20 cases, 13 persons have recovered and fulfilled their isolation requirements per NC DHHS guidance).

\*NOTE: As you review the age and gender data, please be aware this data is preliminary and may change as cases are investigated. Percentages may not sum to 100% due to rounding. Also, the age and gender data are representative of the confirmed cases, not of all COVID-19 cases in Carteret County.
