**Carteret County COVID-19
Additional Confirmed COVID-19 Case
Press Release #51**

Carteret County, NC – On May 14, 2020, Carteret County received an additional confirmed positive case for a total of 36 confirmed cases of COVID-19 in the County. Of the 36 confirmed cases, 9 patients are active cases, 24 of those patients have recovered and have satisfied the NC Department of Health and Human Services (NCDHHS) isolation requirements, and 3 are deceased. Carteret County medical providers, including the Health Department, have collected specimens for COVID-19 testing for 747 patients resulting in 36 positive confirmations, 1 inconclusive, 683 negative results and 27 pending test results. Residents who are experiencing symptoms compatible with COVID-19 such as fever and cough should immediately self-isolate and contact their healthcare provider to determine if they need to be tested.

Total Confirmed Cases: 36 (Of the 36 cases, 24 persons have recovered and fulfilled their isolation requirements per NC DHHS guidance).

*NOTE: As you review the age and gender data, please be aware this data is preliminary and may change as cases are investigated. Percentages may not sum to 100% due to rounding. Also, the age and gender data are representative of the confirmed cases, not of all COVID-19 cases in Carteret County.
