

Key Notes

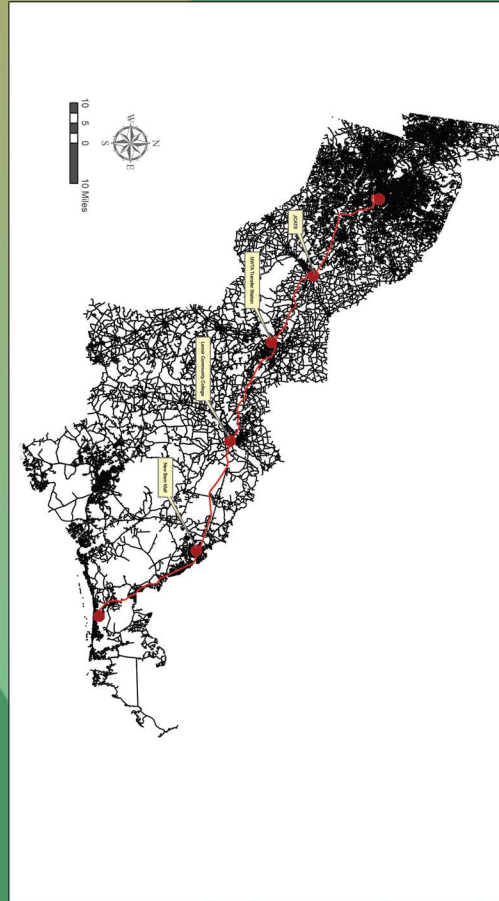
- 1) Downtown and Around is a deviated fixed route, traveling the same route every time.*
- 2) Bus stops are located approximately every 3 blocks along the route; you must be at a bus stop to be picked up or dropped off.
- 3) Prices are per person each way; children 12 years and under ride for free, with a full fare paying adult.
- 4) You must have exact fare; operators are unable to make change.
- 5) Seat belts must be worn at all times; age appropriate child safety seats must be provided by the passenger.
- 6) Please limit the number of packages to what can be placed in another seat.
- 7) Profanity or inappropriate language, eating, drinking or the use of tobacco products and carrying weapons are not permitted.

*In some instances, limited deviations from the route can be made; call first to alert us to your need and location.

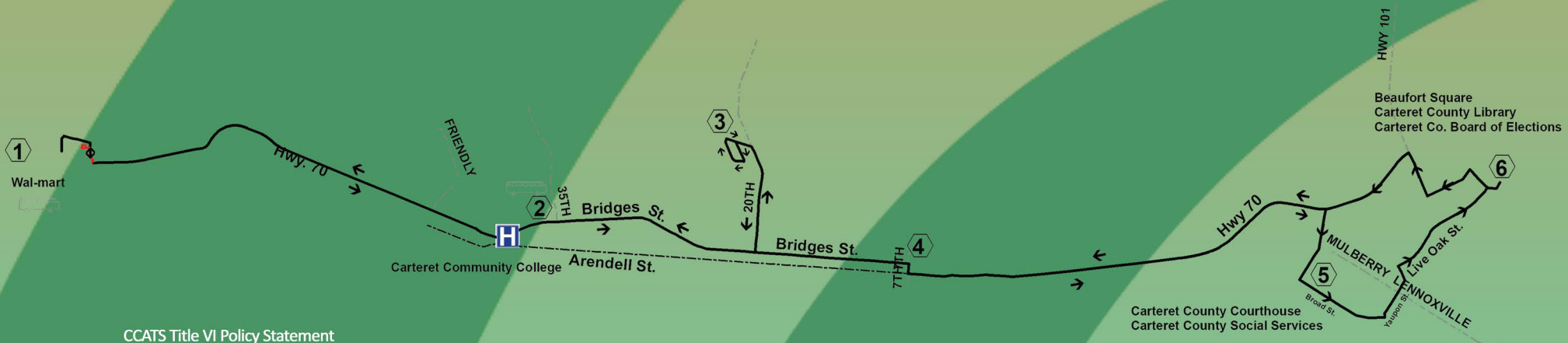
